Department of Energy (DOE) Funding (TAS 89 0222), Bi-Partisan Infrastructure Law Funding (TAS 89 0321), and COVID-19 deobligation of funding (TAS 89 0222) resulting in a net increase to the total obligated amount. The DOE funded amount for this modification includes \$.01 to correct a discrepancy found between Financial Plan #255 and modification 1467 - Pursuant to Article B-2 of the Schedule of contract DE-AC05-76RL01830, the amount obligated by the Department of Energy is increased from \$25,890,226,305.22 to \$26,016,056,278.08, an increase of \$125,829,972.86. This modification results in no other change to the terms and conditions of the subject contract.
