- A. Office of Science:** The purpose of this contract modification is to deobligate funds under the American Recovery and Reinvestment Act of 2009 for the Office of Science Laboratories Infrastructure project entitled "GPP-Infrastructure Upgrades".

- B.** Accordingly, pursuant to Section I, Contract Clause, "Obligations of Funds" and Section B, Contract Clause, B-2, "Obligated Funds", funds in the amount of **\$97.96** are hereby **deobligated** related to Recovery Act activities. The total amount of funds obligated under this contract since the inception is decreased from **\$16,860,091,483.12** to **\$16,860,091,385.16**.
- C.** The specific work funded by this modification is described in the work authorization titled, "GPP-Infrastructure Upgrades" (Project Code #2005380).
- D.** The work described in this modification shall be performed using funds obligated under this contract, which have been appropriated under the American Recovery and Reinvestment Act of 2009, Pub. L. 111-5, and as such, is subject to the special statutory conditions and the additional contractual terms and conditions that were incorporated into the contract at Modification No. A508.
