

- A. Office of Biological and Environmental Research (BER).** The purpose of this contract modification is to realign funding under the American Recovery and Reinvestment Act of 2009 for the Office of Biological and Environmental Research - the Atmospheric Radiation Measurement (ARM) Climate Research Facility initiative (ACRF) project (code 2005090).

Changes in major items of equipment (MIE) funding are necessary to support the Atmospheric Radiation Measurement (ARM) Climate Research Facility initiative (ACRF) project. \$370,000.00 has been converted from capital to operating in support of project 56714. Operating funds are necessary to produce the scientific data products from the new instrumentation. Capital equipment funds are realigned between other equipment and various Major Items of Equipment to reflect actual costs. The affected MIE's are as follows:

- MIE#91TG – Scanning/Multi-Frequency Cloud Radar (Southern Great Plains)
- MIE#91TH – Radman Lidar
- MIE#91TJ – Scanning/Multi-Frequency Cloud Radar (Darwin)(Western Pacific)
- MIE#91TK – Scanning/Multi-Frequency Cloud Radar (Manus) (Western Pacific)
- MIE#91TN - Scanning/Multi-Frequency Cloud Radar (Alaska)
- MIE#91TP - Scanning/Multi-Frequency Cloud Radar (Mobile Facility)
- MIE#91TQ - Scanning/Multi-Frequency Cloud Radar (Mobile Facility #2)

The project code that should be used to track this Recovery Act funding in the Project section of the Accounting Flex Field in STARS/IDW is 2005090.

- B.** Accordingly, pursuant to Section I, Contract Clause, "Obligations of Funds" and Section B, Contract Clause, B-2, "Obligated Funds", funds in the amount of **\$0.00** are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since the inception remains at **\$11,863,740,444.75**
- C.** The specific work funded by this modification is described in Work Authorization Number KP/OR48/9/ARRA-1, Revision 1, titled "the Atmospheric Radiation Measurement (ARM) Climate Research Facility initiative (ACRF) project." (Project Code 2005090).
- D.** The work described in this modification shall be performed using funds obligated under this contract, which have been appropriated under the American Recovery and Reinvestment Act of 2009, Pub. L. 111-5, and as such, is subject to the special statutory conditions and the additional contractual terms and conditions that were incorporated into the contract at Modification No. A508. The funds obligated hereunder shall only be used to accomplish the work as set forth in paragraph C. above and may not be used for any other purpose without the prior written consent of the Contracting Officer.
- E.** The contractor shall complete all Recovery Act Work funded by this modification in accordance with Recovery Act requirements, including the required completion dates specified therein, and by the completion date identified in the approved work authorization for the activity.
