A. Office of Energy Efficiency and Renewable Energy (EERE). This modification is issued to obligate American Recovery and Reinvestment Act (ARRA) of 2009 funds. These funds are made available for the Solid State Lighting Project (Project Code 2004100) (\$3,605,000) which is for providing technical assistance to EERE for the solid state lighting commercialization needs that would speed the market introduction of new and improved solid state lighting concepts. The National Accounts Acceleration in Support of the Commercial Buildings Initiative (Project Code 2004080) (\$100,000) is for the initial project planning and development of solicitation materials for the Commercial Building Partnerships program and Buildings and Appliance Market Transformation Project (Project Code 2004090) (\$100,000) is for the completion of statements of work and planning required for the preparations of mock-ups for web site development for progress of states activities against Recovery Act commitments.
