

The purpose of this contract modification is to obligate funds from the American Recovery and Reinvestment Act of 2009 for the Office of Energy Efficiency and Renewable Energy (EERE) – National Accounts Acceleration in Support of the Commercial Buildings Initiative (Project Code 2004080) and Buildings and Appliance Market Transformation (Project Code 2004090) (See Continuation Page)

**Block 14 "DESCRIPTION OF AMENDMENT/MODIFICATION," continued.**

- A. Office of Energy Efficiency and Renewable Energy (EERE).** This modification is issued to obligate American Recovery and Reinvestment Act (ARRA) of 2009 funds. These funds are made available for the National Accounts Acceleration in Support of the Commercial Buildings Initiative (Project Code 2004080) (**\$13,511,706**) which is to create, test and validate design features that will move commercial buildings towards zero-net energy. The funding will be used to perform all contracting requirements to conduct technical support and interactions with the new design teams, and to provide direct design assistance to Commercial Building Partners. The Buildings and Appliance Market Transformation Project (Project Code 2004090) (**\$2,000,000**) is to improve building operations by transferring the skills to retune large commercial buildings through a series of training programs and development of an online interactive training curriculum. Funds are deobligated under "Solid State Lighting Project (Project Code 2004100)" via Headquarter Letter of Direction, issued by the Office of Energy Efficiency and Renewable Energy in the amount of (**-\$1,020,000**).

The Recovery Act Project titles are National Accounts Acceleration in Support of the Commercial Buildings Initiative (Project Code 2004080) (**\$13,511,706**), and Appliance Market Transformation Project (Project Code 2004090) (**\$2,000,000**). The Solid State Lighting Project (Project Code 2004100) (**-\$1,020,000**). The project codes that should be used to track this Recovery Act funding in the Project section of the Accounting Flex Field in STARS/IDW are 2004080, 2004090 and 2004100 accordingly.

- B.** Accordingly, pursuant to Section I, Contract Clause, "Obligations of Funds" and Section B, Contract Clause, B-2, "Obligated Funds", funds in the amount of **\$14,491,706.00** are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since the inception is increased from **\$12,345,128,213.74 to \$12,359,619,919.74**.
- C.** The specific work funded by this modification is described in Work Authorization Numbers BT-470006-20743-10 Rev. 1, titled, "National Accounts Acceleration in Support of the Commercial Buildings Initiative (Project Code 2004080)", and BT-470006-20744-10 Rev. 1, titled, "Buildings and Appliance Market Transformation Project (Project Code 2004090)".
- D.** The work described in this modification shall be performed using funds obligated under this contract, which have been appropriated under the American Recovery and Reinvestment Act of 2009, Pub. L. 111-5, and as such, is subject to the special statutory conditions and the additional contractual terms and conditions that were incorporated into the contract at Modification No. A508. The funds obligated hereunder shall only be used to accomplish the work as set forth in paragraph C. above and may not be used for any other purpose without the prior written consent of the Contracting Officer.
- E.** The contractor shall complete all Recovery Act Work funded by this modification in accordance with Recovery Act requirements, including the required completion dates specified therein, and by the completion date identified in the approved work authorization for the activity.
