

 The purpose of this contract modification is to obligate funds from the American Recovery and Reinvestment Act of 2009 for the Office of Energy Efficiency and Renewable Energy (EERE) – Concentrating Solar Power (Project Code 2004420), PV Systems Development (Project Code 2004430) and Wind Energy Technology R&D and Testing (Project Code 2004480) (See Continuation Page)

Block 14 "DESCRIPTION OF AMENDMENT/MODIFICATION," continued.

- A. Office of Energy Efficiency and Renewable Energy (EERE).** This modification is issued to obligate American Recovery and Reinvestment Act (ARRA) of 2009 funds. These funds are made available for the Concentrating Solar Power (Project Code 2004420) (**\$747,974**) which is to perform technology development activities including an on-sun, proof-of-concept demonstration of a high-efficiency Solar Thermochemical Energy Storage System based on the integration of compact, process-intensive microchannel reactors and heat exchangers. PV Systems Development (Project Code 2004430) (**\$750,000**) is to increase the performance and durability of thin film Cadmium Telluride (CdTe) solar cells by improvements to the window layer interfaces. Funds are also obligated under Wind Energy Technology R&D and Testing (Project Code 2004480) (**\$30,000**) to serve as advisory (technical expertise) to Honeywell in their development and demonstration of an advanced wind turbine condition based maintenance system.

The Recovery Act Project titles are Concentrating Solar Power (Project Code 2004420) (**\$747,974**), PV Systems Development (Project Code 2004430) (**\$750,000**) and The Wind Energy Technology R&D and Testing (Project Code 2004480) (**\$30,000**). The project codes that should be used to track this Recovery Act funding in the Project section of the Accounting Flex Field in STARS/IDW are 2004420, 2004430 and 2004480 accordingly.

- B.** Accordingly, pursuant to Section I, Contract Clause, "Obligations of Funds" and Section B, Contract Clause, B-2, "Obligated Funds", funds in the amount of **\$1,527,974.00** are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since the inception is increased from **\$12,359,619,919.74 to \$12,361,147,893.74**.
- C.** The specific work funded by this modification is described in Work Authorization Numbers SL-470006-20479-10, Rev. 0, titled Concentrating Solar Power (Project Code 2004420, SL-470006-20477-10, Rev.0, titled PV Systems Development (Project Code 2004430) and WW-470006-20464-10, Rev.0, titled Wind Energy Technology R&D and Testing (Project Code 2004480).
- D.** The work described in this modification shall be performed using funds obligated under this contract, which have been appropriated under the American Recovery and Reinvestment Act of 2009, Pub. L. 111-5, and as such, is subject to the special statutory conditions and the additional contractual terms and conditions that were incorporated into the contract at Modification No. A508. The funds obligated hereunder shall only be used to accomplish the work as set forth in paragraph C. above and may not be used for any other purpose without the prior written consent of the Contracting Officer.
- E.** The contractor shall complete all Recovery Act Work funded by this modification in accordance with Recovery Act requirements, including the required completion dates specified therein, and by the completion date identified in the approved work authorization for the activity.
