A. Department of Health and Human Services (DHHS) National Institutes of Health (NIH). The purpose of this contract modification is to deobligate funds under the American Recovery and Reinvestment Act of 2009 for the National Institutes of Health - Non-Federal Work For Others Agreement for purposes of conducting multiple research and development projects (project code 0000000). Battelle has elected to reduce the amounts of advance payments required due to the approval of the waiver request from the Chief Financial Officer ORO.
