A. Office of Energy Efficiency and Renewable Energy (EERE). This modification is issued to obligate American Recovery and Reinvestment Act (ARRA) of 2009 funds. These funds are made available for the Building Technologies Program Research and Development (Project Code 2004060) (\$3,000,000) which is to perform technological assistance for building energy retrofits based on state-of-the-art cost and performance data and a national comprehensive energy efficiency rating system for both residential and commercial buildings.
