Block 14 "DESCRIPTION OF AMENDMENT/MODIFICATION," continued.

- A. The transfers authorized by this modification within previously obligated funding support The Office of Biological and Environmental Research (Project Code 2005110). \$226,000 is transferred from Miscellaneous capital equipment to MIE 91TU, Atom Probe (\$94,000), and to MIE 91TX, 15T FT-ICR MS system (\$132,000), to enable EMSL to obtain a sputter coating addition to the main atom probe system and a spotter addition to the main 15T FT-ICR MS system.
- B. The work referenced in this modification shall be performed using funds previously obligated under this contract, which have been appropriated under the American Recovery and Reinvestment Act of 2009, Pub. L. 111-5, and as such, is subject to the special statutory conditions and the additional contractual terms and conditions that were incorporated into the contract at Modification No. A508. The previously obligated funds referenced hereunder shall only be used to accomplish the work as set forth in paragraph A. above and may not be used for any other purpose without the prior written consent of the Contracting Officer.
- C. The contractor shall complete all Recovery Act Work funded by this modification in accordance with Recovery Act requirements, including the required completion dates specified therein, and by the completion date identified in the approved work authorization for the activity.
