

A. Department of Health and Human Services (DHHS) National Institutes of Health (NIH). The purpose of this contract modification is to obligate funds under the American Recovery and Reinvestment Act of 2009 for the National Institutes of Health - Non-Federal Work For Others Agreement for purposes of conducting multiple research and development projects (project code 0000000).

- B.** Accordingly, pursuant to Section I, Contract Clause, "Obligations of Funds" and Section B, Contract Clause, B-2, "Obligated Funds", funds in the amount of **\$648,000.00** are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since the inception is increased from **\$12,577,273,539.51 to \$12,577,921,539.51**.
- C.** The specific work funded by this modification is described in National Institutes of Health - Non-Federal Work For Others Agreement for purposes of conducting multiple research and development projects (project code 0000000).
- D.** The work described in this modification shall be performed using funds obligated under this contract, which have been appropriated under the American Recovery and Reinvestment Act of 2009, Pub. L. 111-5, and as such, is subject to the special statutory conditions and the additional contractual terms and conditions that were incorporated into the contract at Modification No. A508. The funds obligated hereunder shall only be used to accomplish the work as set forth in paragraph C. above and may not be used for any other purpose without the prior written consent of the Contracting Officer.
