


Block 14 "DESCRIPTION OF AMENDMENT/MODIFICATION," continued.

- A. Office of Basic Energy Sciences.** This modification is issued to deobligate American Recovery and Reinvestment Act (ARRA) of 2009 funds. The funding is being deobligated to allow for the transfer of the principle investigator from the Pacific Northwest National Laboratory (PNNL) to the Oak Ridge National Laboratory (ORNL) where the principle investigator will continue their research. The funding is used to provide for basic research for transformative energy technologies for the future. This will include basic research needs pertinent to combustion, catalysis, superconductivity, solid state lighting, solar energy utilization, electrical energy storage and geosciences for carbon sequestration. Efforts for this project will be in collaboration with the University of Notre Dame.

The Recovery Act Project title is – Basic Energy Sciences - Energy Frontier Research Centers (Project Code 2005000). The project code that should be used to track this Recovery Act funding in the Project section of the Accounting Flex Field in STARS/IDW is 2005000.

- B.** Accordingly, pursuant to Section I, Contract Clause, "Obligations of Funds" and Section B, Contract Clause, B-2, "Obligated Funds", funds in the amount of **-\$1,100,000.00** are hereby deobligated in support of Recovery Act activities. The total amount of funds obligated under this contract since the inception is increased from **\$12,577,921,539.51 to \$12,576,821,539.51**.
- C.** The specific work funded by this modification was described in Work Authorization Number KC/OR48/9/ARRA-1, titled "Basic Energy Sciences - Energy Frontier Research Centers" (Project Code 2005000), final work authorization for this deobligation will be provided after the modification has been processed per BES HQ.
- D.** The work described in this modification shall be performed using funds obligated under this contract, which have been appropriated under the American Recovery and Reinvestment Act of 2009, Pub. L. 111-5, and as such, is subject to the special statutory conditions and the additional contractual terms and conditions that were incorporated into the contract at Modification No. A508. The funds obligated hereunder shall only be used to accomplish the work as set forth in paragraph C. above and may not be used for any other purpose without the prior written consent of the Contracting Officer.
- E.** The contractor shall complete all Recovery Act Work funded by this modification in accordance with Recovery Act requirements, including the required completion dates specified therein, and by the completion date identified in the approved work authorization for the activity.
