

- B.** Accordingly, pursuant to Section I, Contract Clause, "Obligations of Funds" and Section B, Contract Clause, B-2, "Obligated Funds", funds in the amount of **\$173,794.80** are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since the inception is increased from **\$12,577,131,622.76 to \$12,577,305,417.56**.
- C.** The specific work funded by this modification is described in National Institutes of Health - Non-Federal Work For Others Agreement for purposes of conducting multiple research and development projects (project code 0000000).
