

Obligation Notice 680 Recovery Act: TAS::89 0331::TAS Recovery The purpose of this contract modification is to obligate funds from the American Recovery and Reinvestment Act of 2009 for the Office of Energy Efficiency and Renewable Energy (EERE) – Geothermal Technologies (Project Code 2004190) and PV Systems Development (Project Code 2004430); move funding within the Feedstocks Infrastructure Program (Project Code 2004020) and de-obligate funds from Tax Credit Application Reviewers (Project Code 2004040). (See Continuation Page) Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.

Block 14 "DESCRIPTION OF AMENDMENT/MODIFICATION," continued.

A. Office of Energy Efficiency and Renewable Energy (EERE). This modification is issued to obligate American Recovery and Reinvestment Act (ARRA) of 2009 funds. These funds are made available for Geothermal Technologies – EGS R&D (Project Code 2004190) (**\$500,000**). Federal Lab Support for Recovery Act Transactions ARRA FY 2009 and 48C Tax Credit Application Reviewers (Project Code 2004040) (**\$-51,397**). These funding actions result in a net obligation for this modification of **\$448,603.00**.

B. PV Systems Development (Project Code 2004430) (\$747,974) receives funds redirected from Concentrating Solar Power (Project Code 2004420) (**net change \$0**). Feedstocks Infrastructure program (Project Code 2004020) (**\$350,000**) is moved from operating to capital equipment within the project (**net change \$0**).

The project codes that should be used to track this Recovery Act funding in the Project section of the Accounting Flex Field in STARS/IDW are 2004190, 2004040, 2004430, 2004420, and 2004020, respectively.

C. Accordingly, pursuant to Section I, Contract Clause, "Obligations of Funds" and Section B, Contract Clause, B-2, "Obligated Funds", funds in the amount of **\$448,603.00** are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since the inception is increased from **\$12,595,139,977.23 to \$12,595,588,580.23**.

D. The specific work funded by this modification is described in Work Authorization Numbers GT-470006-20685-10 Rev. 1 and 2 (Project Code 2004190); SL-470006-20479-10 (Project Code 2004430); BM-470006-20852-10 (Project Code 2004020) and 470006-20476-09, Rev. 1 (Project Code 2004040).

E. The work described in this modification shall be performed using funds obligated under this contract, which have been appropriated under the American Recovery and Reinvestment Act of 2009, Pub. L. 111-5, and as such, is subject to the special statutory conditions and the additional contractual terms and conditions that were incorporated into the contract at Modification No. A508. The funds obligated hereunder shall only be used to accomplish the work as set forth in paragraph C. above and may not be used for any other purpose without the prior written consent of the Contracting Officer.

F. The contractor shall complete all Recovery Act Work funded by this modification in accordance with Recovery Act requirements, including the required completion dates specified therein, and by the completion date identified in the approved work authorization for the activity.

G. All other terms and conditions remain unchanged. **[A645]**
