- A. Office of Energy Efficiency and Renewable Energy (EERE).** This modification is issued to obligate American Recovery and Reinvestment Act (ARRA) of 2009 funds. These funds are made available for the Energy Feedstocks Program (Project Code 2004020) which provides funding for work in conducting land use modeling efforts to understand the impacts associated with providing energy feedstocks into alternative fuels production (**\$300,000.00**).
- B.** The project code that should be used to track this Recovery Act funding in the Project section of the Accounting Flex Field in STARS/IDW is 2004020.
- C.** Accordingly, pursuant to Section I, Contract Clause, "Obligations of Funds" and Section B, Contract Clause, B-2, "Obligated Funds", funds in the amount of **\$300,000.00** are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since the inception is increased from **\$12,595,771,085.97 to \$12,596,071,085.97**.
- D.** The specific work funded by this modification is described in Work Authorization Number BM-470006-20469-10, Rev. 0 (Project Code 2004020)
- E.** The work described in this modification shall be performed using funds obligated under this contract, which have been appropriated under the American Recovery and Reinvestment Act of 2009, Pub. L. 111-5, and as such, is subject to the special statutory conditions and the additional contractual terms and conditions that were incorporated into the contract at Modification No. A508. The funds obligated hereunder shall only be used to accomplish the work as set forth in paragraph C. above and may not be used for any other purpose without the prior written consent of the Contracting Officer.
