

- A. Office of Advanced Research Projects Agency – Energy (ARPA-E).** This modification is issued to obligate American Recovery and Reinvestment Act (ARRA) of 2009 funds. These funds are made Office of Advanced Research Projects Agency – Energy (ARPA-E) –High Efficiency Absorption Chilling Using Novel Metal Organic Heat Carriers (Project Code 2010000).

- C.** The specific work funded by this modification is described in AY Certification Request from Headquarters and associated with the original Work Authorization Number 09/CJ000/00/01, Revision 00, titled "Office of Advanced Research Projects Agency – Energy (ARPA-E) –High Efficiency Absorption Chilling Using Novel Metal Organic Heat Carriers (Project Code 2010000).
- D.** The work described in this modification shall be performed using funds obligated under this contract, which have been appropriated under the American Recovery and Reinvestment Act of 2009, Pub. L. 111-5, and as such, is subject to the special statutory conditions and the additional contractual terms and conditions that were incorporated into the contract at Modification No. A508.
