

Office of Energy Efficiency and Renewable Energy (EERE):** The purpose of this contract modification is to deobligate funds under the American Recovery and Reinvestment Act of 2009 for the Office of Energy Efficiency and Renewable Energy - ARRA 48C Tax Credit Applications (project code 2004040).

The project involved is:

- B.** Accordingly, pursuant to Section I, Contract Clause, “Obligations of Funds” and Section B, Contract Clause, B-2, “Obligated Funds”, funds in the amount of **\$88,121.19** are hereby deobligated related to Recovery Act activities. The total amount of funds obligated under this contract since the inception is decreased from **\$13,293,546,964.22 to \$13,293,458,843.03.**
- C.** The specific work funded by this modification is described in work authorization titled, “ARRA 48C Tax Credit Applications” (Project Code 2004040).
- D.** The work described in this modification shall be performed using funds obligated under this contract, which have been appropriated under the American Recovery and Reinvestment Act of 2009, Pub. L. 111-5, and as such, is subject to the special statutory conditions and the additional contractual terms and conditions that were incorporated into the contract at Modification No. A508. The funds obligated hereunder shall only be used to accomplish the work as set forth in paragraph C. above and may not be used for any other purpose without the prior written consent of the Contracting Officer.
